#### 1. About Us - Operator

#### 2. Cookies

A cookie is a small text file that is stored in the user's web browser (e.g., Internet Explorer, Google Chrome, Firefox) on the user's computer (or other internet-enabled device, such as a smartphone or tablet). The information from cookies is only available to the server of the company that created them, and not to other servers. Specifically, we use the following types of cookies:
